### 4. How We Use Your Data

We collect and process personal data for the following purposes:

- To manage and deliver our construction services
- To communicate with clients, suppliers, and subcontractors
- For quoting, invoicing, and payment processing
- To manage contracts and legal obligations
- To maintain records in our CRM system to track enquiries, projects, and communications

Our CRM system is a secure digital platform used to manage business relationships and data efficiently. It helps us keep your information accurate and up-to-date and ensures that communications are timely and relevant.

## 5. Legal Basis for Processing

We rely on the following lawful bases for processing your personal data:

- Consent where applicable, especially for marketing communications

# 6. Data Sharing and Disclosure

## 7. Data Retention

We retain personal data only for as long as necessary for the purposes for which it was collected, including legal, accounting, or reporting requirements. Typically:

- Project and contract records: up to 6 years post-completion
- Financial records: 6 years minimum
- CRM communications: reviewed regularly and deleted if no longer relevant

# 8. Data Security

We take data security seriously and have appropriate measures in place to:

- Prevent unauthorised access, alteration, disclosure, or loss
- Restrict data access to authorised personnel only
- Maintain regular software and CRM updates
- Use encryption and secure backups
- We do not transfer personal data outside of the UK. If such transfers occurred in the future, we would ensure appropriate safeguards are in place.
